

SHELL ROTELLA SUPERRIGS® TRUCK BEAUTY CONTEST (“CONTEST”)

OFFICIAL RULES

- 1. ELIGIBILITY:** To be eligible to enter the Contest, you must: (a) be a legal resident of, and reside within, the fifty United States, the District of Columbia or Canada (excluding Quebec) (b) be the age of majority in his/her state/province/territory of residence at the time of entry, (c) own or lease a “Working Truck” which may or may not be in service as set forth below, and (d) be a MyMilesMatter® member (a “Contestant”). To qualify as a “Working Truck” owner or operator, at the time of registration, the contestant must provide State/Province/Registration US Department of Transportation/Transport Canada authority, truck VIN#, original government Issued vehicle registration card (or duplicate of original) and driver Class A Commercial Driver's License number (“CDL License”). Each contestant must hold a current CDL license and ensure that their Working Truck is only operated by a CDL licensed driver during the entire term of the Contest. If the Contestant is not a MyMilesMatter member, he/she can become a MyMilesMatter member by registering at mymilesmatter.com or mymilesmatter.ca. There is no cost to becoming a MyMilesMatter member.

If a contestant wishes to participate in the Working Truck Category, defined in Rule 3, then the contestant must meet the following criteria: (a) must show that he/she has logged a minimum of 85,000 miles/136,794.24 kilometers annually for the past twelve (12) months on the Working Truck being entered into the Contest, or (b) show documentation that he/she has averaged at least 6,250 miles/10,058.4 kilometers per month over a 6 month period prior to engaging in any customization that had taken the Working Truck out of service (out of service time cannot exceed 6 months prior to competing in the Shell Rotella SuperRigs event), or (c) has logged at least 6,250 miles per month for a minimum of 6 months since completing the customization of the Working Truck and can provide documentation that shows that the Working Truck had averaged at least 6,250 miles/10,058.4 kilometers per month over a 6 month period prior to be taken out of service for customization. Sponsor reserves the right to check ECM module to verify Working Truck eligibility. For the Classic Truck Category, a contestant must comply with the same criteria as the Working Truck Category except that the Working Truck must be 15 years old or older.

Employees of Pennzoil Quaker State Company d/b/a SOPUS Products and Shell Canada Products (collectively, "**Sponsor**") and its parent, affiliate and subsidiary companies, participating advertising and promotion agencies, prize suppliers, and those entities involved in the preparation of materials for, administration and/or execution of this Contest (collectively "**Contest Entities**") and their immediate family members (spouse, siblings, children and parents including step-relations) and/or those living in the same household of such employees (whether or not related) are ineligible.

- 2. REGISTRATION PERIOD/VOTING PERIOD:** The “Registration Period” starts at 12:00 a.m. (CT) on August 10, 2020 and ends at 11:59:59 p.m. (CT) on August 21, 2020. The “Voting Period” starts at 12:00 a.m. (CT) on August 24, 2020 and ends at 11:59:59 p.m. (CT) on September 4, 2020. Sponsor’s computer will be the official timekeeping device of the Contest.
- 3. HOW TO REGISTER FOR THE CONTEST:** During the Registration Period, Contestant must logon to super-rigs.mymilesmatter.com (the “Website”) and answer the question of whether or not the Contestant is a MyMilesMatter member. If the Contestant is a MyMilesMatter member, he/she will be required to fill in his/her e-mail address and password.

To complete registration, each Contestant must complete the following information on the Website: select a “Judging Category” (selected from a drop down menu), truck nickname (optional), vehicle’s license plate number and state, feature notes (optional), check the box on whether or not the Contestant is the owner of the vehicle, select the vehicle's year and make, enter the vehicle's model, Trailer dimensions or overall dimensions of the Tractor/Trailer, total mileage/kilometers, driver's CDL number, DOT number or Canadian governmental equivalent for Canadian Contestants (if the driver does not have a DOT number, then explain), and click to agree to all of the following: Shell reserves the right to request that you provide a copy of an ECM Module report to verify working truck eligibility, I certify that I have Comprehensive General

Liability Insurance, and I understand that by registering for this event I will be required to upload a photo of my Original Government Issued Vehicle Registration card (or Duplicate of Original) as it will be required to compete.

The Contestant must then upload an image of his/her original government Issued vehicle registration card, odometer, and images or videos (optional) of his/her vehicle. Limit one (1) vehicle entry including a total of no more than ten (10) images and two (2) videos of the vehicle. The Contestant must then agree to these Official Rules and sign his/her complete name. A Contestant may post an image or video to his/her social media platform provided he/she uses the **#contest** in any such post.

The vehicle "Categories" are: Tractor Trailer, Tractor and Classic. There will also be awards for the "Most Hard-Working Trucker" and "People's Choice".

To register for the Most Hard Working Trucker, the Contestant must complete his/her registration and click the "Are you the most hard-working trucker? Submit your story now!" link. The Contestant must then answer the following questions: What is the Hardest Part of the Work you do?, what are the toughest conditions you've worked in? and what has "life" thrown at you that makes your job more challenging? Each answer is referred to as an "essay." The Contestant must also answer how many miles/kilometers do you drive your truck per year?

4. SUBMISSION GUIDELINES AND REQUIREMENTS:

- Each image/video/Essay (a "Submission") must be in English;
- Photographs must be in one of the following file formats: .jpg, .jpeg, .gif, and/or .png;
- Each photograph file must not exceed 3 MB;
- Each video must not exceed 10 MB or be longer than 120 seconds, uploaded videos will not be published on the Website;
- The Submission must not contain, facilitate, reference, or use material that is fraudulent, inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous or libelous;
- The Submission must not contain, facilitate, reference or use material that contains prohibited content which shall include, but is not limited to content that promotes, suggests, or encourages:
 - i. gambling, including without limitation, any content related to online casinos, sports books, bingo or poker;
 - ii. the use of firearms/weapons/ammunition, any illegal drugs, prostitution, pornography, nudity, profanity or other adult content, violence, or the use of alcohol or tobacco products;
 - iii. the taking up of arms against any person, government or entity or otherwise challenge or seek to overthrow any government;
- The Submission must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- The Submission must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age;
- The Submission must not show any Confederate flag/symbols, promote terrorist acts such as providing instructions on how to assemble bombs, grenades and other such weapons or provide instructional information about illegal activities;
- The Submission must not defame, misrepresent or contain disparaging or slanderous remarks about Sponsor, its customers or its products, or other people, products or companies;
- The Submission must not contain trademarks, logos or trade dress owned by others (except Sponsor's trademarks, logos or trade dress), or advertise or promote any brand or product of any kind (except Sponsor's products), without permission, or contain any personal identification, such as license plate numbers, personal names, e-mail addresses or street addresses;
- Only the Contestant may appear in a Submission. Submissions with images of other people may be disqualified;

- The Submission must not communicate messages or images inconsistent with the positive images and/or goodwill to which Sponsor wishes to associate; and
- The Submission must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where Submission is created.

NOTE: If any Submission fails to comply with any of these Submission Guidelines and Requirements or any other provisions of these Official Rules, Sponsor/Administrator reserve the right, in their sole discretion, to disqualify the Contestant and the Submission will not be eligible to win.

Each Contestant retains ownership of his/her Submission. Each Contestant hereby grants to Sponsor and its affiliated companies and designated agents a non-exclusive, transferable, perpetual, irrevocable, royalty free, unconditional, fully paid license and right (a) to post and to make, have made, use, copy, reproduce, modify, and create derivative works of any materials provided by the Contestant with the Contestant's Submission or otherwise through the Contest ("Contest Materials"), (b) to publicly perform or display, import, broadcast, transmit, distribute (directly and indirectly), license, offer to sell and sell, rent, lease, or lend copies of the Constant's Submission (and derivative works thereof), and (c) to sublicense to third parties the foregoing rights, including the right to sublicense to further third parties. Additionally, each Contestant consents to the use of the name, statements, photographs, videos, voice recordings and likenesses of himself/herself and any other person appearing in the Contest Materials for publicity purposes, as well as any other purpose associated with the Contest.

Ownership of Submission will remain with the Contestant. Once a Submission is entered into the Contest, any such posting will be deemed made at the direction of the Contestant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act. EACH CONTESTANT REPRESENTS, UNDERSTANDS AND ACKNOWLEDGES THAT HE/SHE WILL NOT BE PAID FOR OR RECEIVE ANY FORM OF COMPENSATION OR ROYALTY (OTHER THAN A PRIZE STATED HEREIN IF SELECTED AS A WINNER) IN EXCHANGE FOR GRANTING SPONSOR THE NON-EXCLUSIVE LICENSE RIGHTS OR FOR ANY SUBSEQUENT USE OF SUCH SUBMISSION BY SPONSOR. If requested, Contestant will sign any documentation that may be required for Sponsor or its designees to make use of the non-exclusive rights Contestant is granting to use the Submission.

- 5. DETERMINATION THE WINNERS:** A panel of qualified judges ("Judges") will score each entry competing in each Category, Tractor, Tractor Trailer and Classic based on the following equally weighted criteria: appearance, design, detail/finish, originality, and workmanship on a scale of 1-100 points for each criteria with the maximum score being 500 points. Judges will also score each entry to determine the "Most Hard Working Trucker". "People's Choice" award winner will be decided by popular vote. Judging will take place during the Voting Period based on the entries submitted online. Please note – all Judges are volunteers and not paid for their time. Additionally, the scores assessed by any Contestant is a subjective score based solely on the Judges' personal evaluations of that truck based on the appearance, design, detail/finish, originality and workmanship compared to other trucks competing in the same category(ies). Decisions of the Judges and Sponsor are final and binding. If there is a tie, the entity with the highest score in "appearance" will be declared the winner.

Anyone who is a MyMilesMatter member can vote for the People's Choice award by visiting www.mymilesmatter.com/superrigs/peopleschoice for United States members and www.mymilesmatter.ca/superrigs/peopleschoice for Canadian members, then he/she must click on the "Cast Your Vote" link next to the image and follow the instructions to cast his/her vote during the Voting Period. Limit one vote per calendar day during the Voting Period. A calendar day begins at 12:00 AM CT and ends at 11:59 PM CT during the Voting Period. If a person votes for more than one image per day by using multiple/different email addresses, identities, and logins, cheating or fraud, through a sweepstakes club or similar entity, or any other unauthorized methods, all of his/her votes may be disqualified. Votes received from any person or e-mail address or household in excess of this limitation will be void. Votes generated by script, BOT, macro or other automated means are void. Voting must be completed by the actual person casting the vote. A person may not vote on behalf of another person. Subsequent votes during a calendar day by a single voter or e-mail address will be disqualified. Votes intended to impact the integrity of the voting

process as determined by Sponsor in Sponsor’s sole discretion are void. Payment or other consideration in exchange for votes is prohibited. Sponsor will count the votes and the vehicle with the most votes will be the potential winner. In the event of a tie, the winner is decided by the Judges.
